In reference to the above stated :-

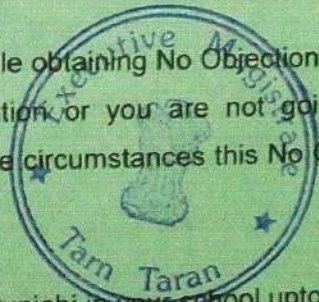
2. As per documents along with affidavit submitted by your school management, recommendation of District Education Officer (SS Tarn-Taran) and Director Education Department (SS Punjab, Chandigarh) after considering the matter thoroughly by Punjab Govt. herby issue No Objection Certificate on the terms and conditions as given below:-

1. That in future if it is found that while obtaining No Objection Certificate, you have made application on the false information or you are not going to abide by the terms mentioned in the affidavit. In these circumstances this No Objection Certificate can be withdrawn at any time.

2. That it will be essential to teach Punjabi in your school upto 10th standard and C.B.S.E New Delhi shall arrange to take the examination of Punjabi in such schools and it is further stated that if you fails to do so No Objection Certificate will withdrawn immediately.

3. School management will abide for the notifications as per the R.T.I Act,2009 issued by Punjab Govt. and follow the rules and regulations under the R.T.I ACT,2009.

4. That after obtaining the affiliation of CBSE New Delhi the school management shall abide by to pay the salaries and other allowances to the teaching and non-teaching staff as per Govt. employees pattern. In case of failure this No Objection Certificate shall be withdrawn immediately.



5. Management and yourself will ensure this thing at any time District Education Officer of your District or any Senior Officer of the Education Department is required to obtain any information, you shall provide the required information and you will also co-operate as per need.




